

Birthrights raise concerns about mental capacity and human rights in maternity care

Recent months have seen a spate of Court of Protection cases permitting Caesarean sections on women who were deemed to lack – or be at risk of losing – mental capacity under the Mental Capacity Act 2005.

Birthrights is concerned about the human rights issues which arise in these cases. The charity is working with obstetricians, lawyers, midwives and academics to improve care for pregnant women whose mental capacity is in question and support for healthcare providers working with women in this situation.

CAJ raise racial discriminatory nature of cross-border checks in Ireland

CAJ (Committee on the Administration of Justice) runs an Equality Duty Enforcement Project which supports civil society

CAJ is currently using the Equality Duty to raise the equality impacts of border immigration checks - particularly their racially discriminatory nature - on Translink bus services (Translink runs bus/train services between the North and South) and have submitted a complaint to the Equality Commission.

Migrants' Law Project launch podcast about human rights law in action

"It can be done" is a new podcast series exploring how the law can be used for social change produced by the **Migrants' Law Project** in partnership with openDemocracy.

It looks at the work of lawyers, activists, and others during the 'refugee crisis' of 2015, telling the story of how people and groups came together to use strategic litigation to open up safe and legal routes to family reunion for refugees trapped in camps on the European mainland.

Public Law Project is awarded funding towards access to justice in Wales

The <u>Public Law Project (PLP)</u> has been awarded funding over three years to work towards improving access to justice in Wales.

PLP will work with civil society organisations working with vulnerable groups to develop coordinated referral pathways to specialist help; bring cases and undertake advocacy and policy work.



Sustain progress on the Right to Food campaign

Sustain are – with the support of a grant from the Foundation – leading a campaign for the Right to Food with Just Fair, Nourish Scotland and the Centre for Health and Society at the University of Newcastle. Recent exciting developments include:

- The Liberal Democrats and the Labour Party have now made commitments to incorporate the Right to Food into law if they get into power.
- The Chief Medical Officer has adopted the concept of the Children's Right to Food into her radical ideas for tackling child obesity.

The Right for Food campaign is also working closely with food aid organisations to ensure that a no-deal Brexit does not push people into more food hardship. **More about this here**.

Using the law to create change – new resources from The Children's Society

In July 2018, the Government conceded a case brought by The Children's Society in 2013 to bring support for migrant children back into the scope of legal aid. Last month, the changes they achieved were passed into law.

They've produced a video about some of the key considerations in taking a judicial review – and a how-to guide with some top tips.
